

WAIVER of LIABILITY and ASSUMPTION OF RISKS



Green Ink is a program of Green Works in Kansas City. Being a volunteer for Green Ink is an activity with risks for injury. I affirm that I have no physical or psychological conditions that would create risk(s) for myself or others in connection with this volunteer activity. I understand that the volunteer work may be inherently dangerous and has risks that include, but aren't limited to, those created by motor vehicle traffic; walking on uneven ground or sidewalks, and/or in areas with exposed roots or other loose footing; the use of garden or trash collecting tools; falling or blowing debris from trees and limbs of trees; exposure to plants and/or insects that cause allergic reactions (including poison ivy) and the effects of weather conditions, including high heat and/or humidity, sun, cold, wind, snow, rain or ice. Therefore, I assume any and all risks directly or indirectly associated with working as a volunteer for Green Works in Kansas City's Green Ink program. I understand that I am solely responsible for my own safety both on the premises and in traveling to and from the volunteer work sites.

I authorize the Green Works staff or volunteers to furnish and/or obtain emergency medical treatment for me if necessary during participation in the Green Ink program and I release and forever discharge Green Works and all Green Works' partners from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with a Green Works program.

I grant and convey unto Green Works and partners all right, title, and interest in any and all photographic images and video or audio recordings made by Green Works or program partners during Green Works activities including but not limited to any royalties, proceeds, or other benefits derived from such photographs or recordings.

Being aware of the above facts, I hereby for myself, my heirs, executors, administrators or anyone else who might claim on my behalf, covenant not to sue, and do release Green Works in Kansas City, and all relevant Green Works in Kansas City partners or event host communities, and their employees, representatives, successors or assigns, from any and all claims or liability for death, personal injury or property damage of any kind or nature whatsoever arising out of, or in the course of, my participation in the Green Ink program.

I understand that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Missouri, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Missouri. In the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
